



Miter's Sustainability Policy

1.0 The United Nations Sustainable Development Goals are a series of call to actions to help progress the global community towards a more positive future. Recognizing some of the world's biggest problems such as poverty and climate change, these issues are addressed with strategies that interconnect governments, industries and communities around the world. Broken down, each goal has 8 -12 targets that are assessed yearly with a combination of tools used to track and measure progress.

2.0 The Sustainable Development Goals, (SDG), comprise 17 goals and related targets for 2030 to address the shared global challenges of poverty, inequality, climate, protecting the natural environment, prosperity, peace and justice. The SDGs are Government commitments with business having a vital role as partners for progress.

3.0 Although a single location, small business, Miter has just celebrated 21 years in business in Newport, South Wales and has contributed to the local economy in that time, and supplied clients throughout the UK. Miter is therefore in a position, in its small way to align with 8 SDG goals such that it will play a part in the UK's contribution to the SDGs.
